By signing this document, the Buyer confirms and agrees:

- The Buyer has requested that all vehicles and related documents/accessories are to be delivered to the alternative address, being located in the confines of Buyer's country of EU VAT registration.
- The Buyer further agrees that the address provided is controlled or managed by the Buyer, or by an agent under instruction of the Buyer and is able to safely and securely take delivery of motor vehicles at this address.
- The Buyer provides in attachment to this form a proof of "ownership" of the alternative address, such as a copy of the rental and/or logistics contract entered with the agent, in case the address is not controlled or managed by the Buyer himself.
- The Buyer agrees to take full responsibility of all vehicles after delivery has been fulfilled to the specified receiving address. This means that the handover of the vehicle to the authorised receiving party replaces the handover to the buyer, so that ownership has been transferred to the buyer and the purchase contract has thus been fulfilled on both sides. There are and will be no purchase agreements for the delivered vehicles between buyer and the receiving party. Regular claim conditions, esp. deadlines, according to terms & conditions of the Seller, still apply.
- CMR's must be returned to BCA and validated under standard procedures along with completing and returning a receipt of delivery form where required. Stamp and signature on all CMR's must relate to the Buyer.
- In case the alternative delivery address is not owned by the buyer but rented or in case the alternative delivery address is a supplier of the buyer: The landlord/lessor or supplier (hereinafter referred to as "Receiving Party") herewith confirms that it is receiving the vehicles on its facilities on behalf of the Buyer in accordance with the rental agreement / supplier agreement in place between Buyer and Receiving party.
